the questionnaire somewhat biased towards your group and its ideologies with its blunt yes/no answers. I get the impression you feel everyone should support your projects. I respond as follows:

1. Global warming and cooling has occurred in varying cycles over thousands and millions of years. The extent of recent human contribution to the warming side is probably caused by the growing world population - more people need to be kept warm and cool as we II as fed and this requires resources. Until world population slows or reduces then more energy will be needed to keep us all comfortable and living a lifestyle we enjoy.

2 The development of renewable energy is fine. I have no problem with it as long as developments are compatible with their location - this includes any impacts on neighbours. There have been many contentious issues with wind tower locations in the region as you would know. Solar does have benefits and I believe will emerge as the dominant renewable energy source in time as I previously stated (GP ost 17 July 2015 p8).

3 & 4 . I am not clear what business model community energy projects operate under - to me it sounds like ideology. Energy supply and production is the domain of State and Federal government portfolios, not the Council. The Council has obligations to deliver the regular municipal services that we are familiar with and I believe that some improvements could be made - like better recycling being achieved. That would be a plus for the environment . If the community wants to contribute to "community energy" projects as you describe them then that's fine but I don't favour additional Council resources being tied up in them. I don't see the Council being obligated to partner or subsidise your projects. The Council should assess any energy generation developments on their merits as per their development assessment obligations. The Council has already supported your project to date (detail I am not aware of) and contributed to renewable energy issues by solar panels on the roof of the Council offices and providing space for Tesla recharging points at the Tourist Centre . It has probably done some other support that I am not aware of.

5. I would be happy to support initiatives that were cost neutral to Council. As I said above, energy production is the domain of State and Federal Governments. This includes renewable energy. I don't intend supporting any further Council resources towards it unless it is cost neutral or the Federal and State Governments compensate the Council. There are lots of unsealed rural roads and other community projects the Council has committed in forthcoming capital works which Council resources should be applied towards. I support development application fees for all development proposals - everyone has to pay. I agree with the Council's recent decision to charge CE4G with DA fees for your development proposal and I don't see why any project should be exempt from DA fees nor should other ratepayers or developers carry the cost of development assessment for others.
